HEALTHY SCHOOL MEALS

Hull City Council have introduced healthy school meals which represent good value. All meals meet the latest government's food standards.

For primary children there is a set charge of £1.30 per meal and for this pupils receive a healthy main course, pudding and a drink.

All primary children receive a piece of fruit each day (free of charge). Over 80% of primary schools also provide free breakfasts (at breakfast clubs).

Secondary children may choose from a range of healthy food and drink items which are individually priced. Secondary children who qualify for free school meals can spend up to £1.80 per meal.

School meals are subsidised by the Council and the above charges are amongst the lowest in the country.

Who can claim free school meals?

Parents or carers in receipt of:

- Income Support, or
- Jobseekers Allowance (income based), or
- Child Tax Credit (but **not** Working Tax Credit) with an annual income of £16,190 or less, or
- Income Related Employment and Support Allowance (ESA-IR), or
- Guaranteed element of State Pension Credit or, who are
- Asylum Seekers (supported by the National Asylum Support Service)



In addition children must attend a school within Hull on a full time basis up to the age of 16 years or attend a sixth form school.

How do I apply?

The parent or carer who receives the qualifying benefit needs to complete an application form (form EWB1). Forms are available from all Customer Service Centres (see the map on the back page).

You can also obtain a form from your child's school or download a form from the Council's website. After filling in the form you can either:

- Post it to Welfare Benefits, or
- Some schools will check your form and then send the form onto the Welfare Benefits Team, please ask your school.
- Customer Service Centres will check your form and then send the form onto the Welfare Benefits Team.

Unless you are applying on the basis of Child Tax Credit you do not need to send any documentary evidence of income with your form. We will make the necessary checks on your behalf.

If you are applying on the basis of Child Tax Credit you need to submit a copy of your latest Tax Credit Award Notice with form EWB1.

Do I need to reapply?

No, we will undertake checks on your behalf. Therefore free meals will continue to be available to your children throughout their school life unless your benefits stop or your asylum status changes. Should this occur we will write to advise you when meals will stop.

Change of circumstances

It is important that you let us know of any changes in your circumstances: eg change of address, name, school, younger children starting school, or benefits stopping.
